Aitkin County:	All except the towns of Hill City, Haypoint, Jacobson and Swatara.
Anoka County:	Everything north of County Road 24 including the City of St. Francis.
Beltrami County:	All except the towns of Jelle, Thorhult, Fourtown, Malcolm and Carmel.
Benton County:	All
Carlton County:	All
Cass County:	All
Chippewa County:	In Chippewa County, all east of Minnesota State Highway 277 and Minnesota State Highway 23 including the city/town/township of Granite Falls.
Chisago County:	In Chisago County, all areas north of State Highway 95, excluding the cities/towns/townships of Almelund and Palmdale.
Clearwater County:	All
Cook County:	All
Crow Wing County:	All
Douglas County:	All
Hubbard County:	All
Isanti County:	All
Itasca County:	The towns of Alvwood.
Kanabec County:	All
Kandiyohi County:	All
Koochiching County:	The cities/towns of Northome, Mizpah, Wildwood and Gemmill.
Lake County:	All
Meeker County:	All of Meeker County north of US Highway 12, excluding all cities/towns and accounts on US Highway 12.
Mille Lacs County:	All
Morrison County:	All

Pine County:	All
Polk County:	Only the cities/towns of Trail and Gully.
Renville County:	All
Sherburne County:	All
St. Louis County:	In St. Louis County, bounded on the north by the town of Silica, east to the St. Louis County line including the towns of Fairbanks and Basset.
Stearns County:	All
Todd County:	All of Todd County except the townships of West Union, Kandota, Gordon, the portion of Little Sauk Township lying west of County Road 11, the portion of Leslie Township lying south of County Road 36, and the portion of Reynolds Township lying south of County Road 36 and west of County Road 11.
Wadena County:	In Wadena County, the area south and east of the intersection of the Wing River and the southern county line, follow the river northeast to County Highway 4, then follow County Highway 4 east to the county line.
Wright County:	The town of Rassat on Wright Cty Rd 35. Also, starting at the intersection of MN Highway 55 and the Stearns/Wright County line, go South East on MN Highway 55 to the city of Buffalo (including town and accounts on MN Highway 55). Then east on Wright Cty Rd 35 to the Wright /Anoka county line (including the town of St. Michael). Scott County: All of Scott County excluding the cities of Belle Plain, Jordan, New Prague and Union Hill.
